1. Briefly describe the field experience. What did you learn about technology coaching and technology leadership from completing this field experience?

For my field experience I worked with the administrative staff and media specialist to create a New Teacher Institute at Sprayberry High School. The New Teacher Institute began with the creation of a Microsoft OneNote notebook to help address the specialized needs of teachers new to Sprayberry High School. The notebook included specialized information such as contact information, training materials, and information about the school. The notebook incorporated various forms of media including PowerPoints, charts, word documents and web links.

The creation and use of the OneNote was only one aspect of the New Teacher Institute. Along with the notebook, I also worked with the media specialist to give a training session for new teachers. The training sessions were designed to be ongoing throughout the entire school year. The first training meeting focused on training the new teachers on how to access the OneNote and the information within it. Along with training the teachers how to use the Microsoft OneNote, I also offered additional technology training. I introduced the teachers to the new technology resources available. Additional trainings were offered on key technology and data collection tools available to teachers. Teachers were given an Excel Survey to identify technology tools they would be interested in receiving additional training on.

After completing my field experience I learned that the needs of a diverse school population are very individualized. Teachers and students alike require learning experiences that directly address their individual leaning needs and goals. It is important to staff and design training sessions that address the individual needs of the population. I also learned that it is extremely important to make certain that the concerns of everyone are heard. It is also important to follow up and make certain that no one feels isolated or left out, especially new teachers.

Receive constructive criticism from others and create consensus to keep the New Teacher Institute moving forward. I also learned the value of listening to concerns of others and work as a technology coach, aiding them as they use new technology tools.

Dispositions - I learned the importance of remain patient and calm working with others to design and develop professional learning opportunities. It is extremely important to make sure that everyone feels as though there concerns and opinions are valued as we work towards a common goal.
